### Overview

Danielle Riera focuses her practice on complex litigation defense, including asbestos litigation. Her work often requires acting as a pseudo historian to support both motion practice and trial strategy.

Beyond her asbestos work, she has experience handling general liability, premises liability, products liability, and other toxic tort liability matters.
