Overview

Kelly Martin Malone has more than 26 years of trial and litigation experience. A former prosecutor, Kelly's extensive trial experience also includes convening numerous grand juries and conducting scores of bench and jury trials, giving her an edge over her competition in the courtroom.

Kelly is one of the leaders of the Design Professionals Litigation Group. She represents owners, construction managers, general contractors, design professionals, subcontractors, and consultants in complex construction disputes, ranging from catastrophic jobsite accidents to multimillion-dollar cost overrun disputes. She assists clients with drafting and negotiating construction contracts. She represents insurance companies and their insureds accused of tort claims, as well as businesses involved in commercial disputes, and helps defendant-clients and their insurers set litigation budgets and reserves. She advises clients on risk management and insurance issues, and helps companies draft and implement employment, safety, and policy and procedure manuals. She also helps businesses defend discrimination claims and with other employment issues.
