Beyond her legal career, Laurelly is an accomplished marathoner, having earned the Six Star Medal by completing all six Abbott World Major Marathons and seven Boston Marathons. She is actively involved in the San Francisco Ballet Auxiliary, previously serving as Chair of the education and outreach program for students and trainees.
