### Overview

As an essential part of complex practice in the electronic age, Tim regularly advises clients on the latest e-discovery best practices, including legal holds, data preservation and data production, working with e-discovery vendors and consultants, and managing e-discovery in anticipation of, during and after litigation and particularly regarding the sensitivities of government investigations. Tim served for two years as the law clerk to US Magistrate Judge Joyce London Alexander Ford in the US District Court for the District of Massachusetts and throughout his career has engaged in extensive pro bono work representing indigent clients in family law, real property evictions, Social Security benefit, and asylum cases.
