### Overview

Chris Massenburg is a partner based in MG+M's New York and New Orleans offices. His practice primarily focuses on environmental, toxic tort, products, premises, and general liability litigation. Chris serves as National Coordinating Counsel (NCC) and National Trial Counsel (NTC) in various toxic tort-related litigation (with a focus on talc and asbestos-related claims). In these roles, multiple companies rely on Chris to spearhead the development and execution of national defense strategies and manage their complex, multi-jurisdictional dockets.

Chris has tried cases in Louisiana, California, New York, New Jersey, Massachusetts, Alabama, Texas, Illinois, Iowa, Georgia, Florida, South Carolina, Pennsylvania, Virginia, Kentucky, Maryland, Mississippi, Delaware, Washington, Wyoming, West Virginia, Oregon, and Utah. He has defended his clients in numerous cases as lead trial counsel and has secured multiple zero-dollar defense verdicts by successfully showing juries that his clients did not do anything wrong. Specifically in asbestos-related litigation, Chris has tried cases in 22 states for numerous clients and has represented a diverse set of asbestos-related liabilities nationwide, including: friction (brakes, clutches), gaskets, packing and related equipment (valves, pumps, boilers, digesters, tanks, turbines), joint compound, floor tile, AC pipe, resin pipe, HVAC, PPE (respirators), commercial and military aircraft, electrical equipment, typecasting machines, plastics and molded materials, premises, and contractors. This work has provided Chris with a deep knowledge of the history and science available to demonstrate his clients' innocence, which he uses to innovate new ways to protect all of the companies that trust him with their defense.

In relation to cosmetic talc litigation, Chris (with his partner, Lindsay Weiss) led the trial teams that won unanimous defense verdicts in the first cosmetic talc jury trials in both Chicago and Portland.

Even when trial is not desired, Chris' experience at all levels of simple and complex litigation allows him to provide his clients with a comprehensive defense for their cases. Chris has been retained by clients to reevaluate their litigation strategies; develop and defend fact, corporate, and expert witnesses in deposition and trial; negotiate the resolution of multi-million-dollar risks; and to step in and try high stakes cases, even on short notice.

Licensed to practice law in Louisiana, New York, New Jersey, California, Pennsylvania, Texas, Mississippi and Tennessee, Chris earned his JD in 2000 from Tulane University Law School, and also achieved a certification in maritime law. Chris has served on the Trial Advocacy faculty of both Tulane and LSU law schools, is a current faculty member of the National Institute for Trial Advocacy (NITA), a member of ABOTA, and board certified in both Civil Law Trial and Civil Practice Advocacy by the National Board of Trial Advocacy.
