As Amaryah was building her practice and demonstrating her leadership capabilities, she was also having important conversations and implementing internal efforts to create a more inclusive firm culture. Her proactive role in the diversity, equity, inclusion and belonging (DEIB) space garnered attention from firm leadership, and she was appointed chief diversity officer. Leading the firm's DEIB efforts, Amaryah founded the firm's DEIB Partner Committee, DEIB Roundtable, pro bono committee and the national Women's Forum, which she co-chairs. In addition to her efforts to make MG+M a more inclusive workplace, Amaryah prioritizes helping women through pro bono work and regularly supports charitable organizations serving women and the community.
