Not only did my male mentor ([MG+M Partner [Max Swetman](#)] who I'm grateful to have now worked alongside for many years) call opposing counsel out on this poor behavior, but he insisted that opposing counsel treat me with respect and professionalism going forward. While opposing counsel's behavior remained unchanged, my male mentor made me feel supported, validated, seen and appreciated as a woman in the legal profession."

Cassidy: "For my first ever trial, I was lucky enough to be part of an all-female trial team. The MG+M partners leading the team, [Jennifer Judin](#) and [Lindsay Weiss](#), are outstanding examples of courtroom conduct. I am acting as the second-chair attorney in an ongoing trial led by Jennifer. She takes every opportunity to assure I am developing my skills as a trial attorney, gives me the chance to make arguments on behalf of our clients and offers enthusiastic support as I take on trial work for the first time. Especially in a predominantly male-counsel trial, I am incredibly grateful to have such a zealous and highly regarded advocate on my team. The support of a successful female attorney has already shaped my trial career throughout the first year of being an attorney and makes me excited to go to the courtroom every day."
