### S. 4846- Nursing Home Pandemic Protection Act

• Committee: Senate- Finance

• Introduced: 10/22/2020

- Latest Action: Introduced on 10/22/2020 and referred to Committee on Finance.
- Summary:
  - O This Bill is for the purpose of establishing requirements for skilled nursing facilities, nursing facilities, and assisted living facilities to address the outbreak of COVID-19. Specifically, the Bill requires these facilities to establish crisis plans and to maintain at least a 30-day supply of personal protective equipment to respond to the outbreak.

#### H.R. 8070-PRINT Act

- Latest Action: Introduced on 8/18/2020 and referred to House Committee on Small Business.

  - This Bill is for the purpose of including the cost of print production of local media as an allowable use for funds disbursed to certain newspaper publishers under the Paycheck Protection Program to support small businesses in response to COVID-19.

### H.R. 8015- Delivering for America Act

- Committee: House- Oversight and Reform
- Introduced: 8/11/2020
- Latest Action: Introduced on 8/11/2020 and referred to House Committee on Oversight and Reform. Passed House on 8/22/2020. Received in Senate in 9/8/2020.
- Summary:
  - This Bill is for the purpose of prohibiting the U.S. Postal Service (USPS) from making changes to operations or levels of service from those that were in effect on January 1, 2020. Specially, the Bill states that the USPS may not, during the period beginning on enactment of this Bill and ending on the last day of the COVID-19 public health emergency or January 1, 2021, whichever is later, from implementing or approving any change to the operations or the level of service that would impede prompt, reliable and efficient services.

# S.4216- KEEP Telehealth Options Act of 2020

- Introduced: 7/20/2020
- Latest Action: Introduced on 7/20/2020, read twice, and referred to Committee on Finance.
- Summary:
  - This Bill is for the purpose of requiring the Department of Health and Human Services and the Government Accountability Office to report on the availability and effects of expanded telehealth services under Medicare, Medicaid, and the Children's Health Insurance Program during the COVID-19 public health emergency.

### S.4209- Protecting Nonprofits from Catastrophic Cash Flow Strain Act of 2020

- Introduced: 7/2/2020
- Latest Action: Introduced on 7/2/2020. Passed Senate on 7/2/2020. Passed House on 7/9/2020. Presented to President on 7/22/2020. Signed by President on 8/3/2020. Became Law on 8/3/2020.
- Summary:
  - This Bill is for the purpose of permitting certain governmental entities, federally recognized tribes, and nonprofit organizations to make up front payments of 50% of unemployment benefits into the state Unemployment Trust Fund to be used exclusively to reduce such payments resulting from the COVID-19 pandemic.

#### S.4171- Calculate PPP Forgiveness Act of 2020

- Introduced: 7/2/2020
- Latest Action: Introduced on 7/2/2020, read twice, and referred to Committee on Small Business and Entrepreneurship.
- Summary:
  - This Bill is for the purpose of requiring the Small Business Administration to establish or certify an online calculator that allows a recipient of assistance under the Paycheck Protection Program established to support small businesses in response to COVID-19 to (1) estimate the amount of loan forgiveness for which they are eligible, and (2) assist with their application to request loan forgiveness.

### S.4125- Paycheck Protection Program Extension and Modification Act of 2020

- Committee: Senate- Small Business and Entrepreneurship
- Introduced: 7/1/2020
- Latest Action: Introduced on 7/1/2020, read twice, and referred to Committee on Small Business and Entrepreneurship.
- Summary:
  - This Bill is for the purpose of extending the Paycheck Protection Program to support small businesses in response to COVID-19 through December 31, 2020 and authorizing additional lending under the program.

- Latest Action: Introduced on 6/30/2020. Passed Senate on 6/29/2020. Passed House on 7/1/2020. Presented to President on 7/2/2020. Signed by President on 7/4/2020. Became law on 7/8/2020.
- Summary:
  - This Bill is for the purpose of extending the application period for the Paycheck Protection Program established to support small businesses in response to COVID-19 through August 8, 2020.

## S.4091- Emergency Aid for Returning Americans Affected by Coronavirus Act

- Committee: Not referred to committee.
- Introduced: 6/29/2020
- Latest Action: Introduced on 6/29/2020. Passed Senate on 6/29/2020. Passed House on 6/29/2020. Presented to President on 7/1/2020. Became law on 7/13/2020.
- Summary:
  - This Bill is for the purpose of increasing and revising the maximum amount of funding available for fiscal year 2020 pertaining to temporary assistance for U.S. citizens and their dependents who are returning from foreign countries due to a crisis and are without available resources. In providing temporary assistance during COVID-19, the Bill states only certain members of the Commissioned Crops of the Public Health Service shall have direct, in-person contact with those receiving assistance.

- Latest Action: Introduced on 6/15/2020 and referred to House Committee on Small Business.
- Summary:
  - This Bill is for the purpose of modifying the Paycheck Protection Program, established to support small businesses in response to COVID-19. The Bill will specifically expand the program to encompass any nonprofit organization regardless of size and strike the affiliation requirements applicable to nonprofit organizations and veterans organizations.

#### H.R. 7216- Small Business PPE Tax Credit Act

- Committee: House- Ways and Means
- Introduced: 6/15/2020
- Latest Action: Introduced on 6/15/2020 and referred to House Committee on Ways and Means.
- Summary:
  - This Bill is for the purpose of allowing small businesses a tax credit for the cost of qualified personal protective equipment, up to \$25,000 in a taxable year. The entities eligible for this tax credit include farms, nonprofit organizations, veterans organizations, and Tribal business concerns. The Bill defines "qualified personal protective equipment" as the cost of equipment to reduce the risk of COVID-19 including gloves, face coverings, cleaning supplies, and other protective gear.

#### H.R. 7197- RESTAURANTS Act of 2020

- Introduced: 6/15/2020
- Latest Action: Sponsor introductory remarks on 6/29/2020.
- Summary:
  - This Bill is for the purpose of temporarily establishing and providing funding for the Restaurant Revitalization Fund. The Department of the Treasury shall makes grants to eligible food and beverage sellers to cover specified costs. The amount of such a grant shall be the amount of (1) any emergency grant received for an economic injury disaster loan, or (2) any paycheck protection loan amount forgiven under the Paycheck Protection Program established to support small businesses in response to COVID-19.

#### H.R. 7175- Paycheck Protection for Producers Act

- Committee: House- Small Business
- Introduced: 6/11/2020
- Latest Action: Introduced on 6/11/2020 and referred to House Committee on Small Business.
- Summary:
  - This Bill is for the purpose of modifying the Paycheck Protection Program, established to support small businesses in response to COVID-19 by allowing certain farmers to calculate or recalculate their paycheck protection loan amount based on 2019 gross income.

### H.R. 7179- Pandemic Liability Protection Act

- Committee: House- Judiciary
- Introduced: 6/11/2020
- Latest Action: Introduced on 6/11/2020 and referred to House Committee on Judiciary.
- Summary:
  - This Bill is for the purpose of exempting certain health care and food providers from liability for ay act or omission retaining to harm arising from exposure by, COVID-19 during the public health emergency. However, the Bill additionally states that this exemption does not apply with respect to acts or omissions that constitute willful or criminal misconduct, gross negligence, reckless misconduct, or conscious and flagrant indifference to the rights or safety of the individual harmed.

# H.R. 7093- PPP Accountability Act

- Latest Action: Introduced on 6/4/2020 and referred to House Committee on Small Business.

  - This Bill is for the purpose of requiring the Small Business Administration (SBA) to publish on its website certain information regarding any loan of \$1 million or greater made under the Paycheck Protection Program established to support small businesses in response to COVID-19.

#### H.R. 7058- Rewarding American Workers Act of 2020

• Committee: House- Ways and Means

• Introduced: 5/28/2020

- Latest Action: Introduced on 5/28/2020 and referred to House Committee on Ways and Means.
- Summary:
  - This Bill is for the purpose of allowing employers a payroll tax credit for bonuses paid to employees whose wages did not exceed specified levels during the period beginning March 13, 2020 through July 31, 2020, or the end of the COVID-19 pandemic, and who worked for the entire period.

#### H.R. 7032- Skills Renewal Act

- Committee: House- Ways and Means
- Introduced: 5/27/2020
- Latest Action: Introduced on 5/27/2020 and referred to House Committee on Ways and Means.
- Summary:
  - This Bill is for the purpose of allowing eligible individuals a refundable tax credit for expenses paid for qualified training services. The tax credit is refundable up to \$4,000 in a taxable year. The Bill defines "qualified training service" as a course or program of study that is listed in the provisions of the Workforce Innovation and Opportunity Act, or that relates to computer science, technology, or another high need area. The Bill defines "eligible individual" as an individual unemployed or furloughed in 2020, but was otherwise able to work and applied for pandemic emergency unemployment compensation related to COVID-19.

### H.R. 7010- Paycheck Protection Program Flexibility Act of 2020

- Committee: House- Small Business; Ways and Means
- Introduced: 5/26/2020
- Latest Action: Became Law. Signed by the President on 6/5/2020. Passed Senate on 6/3/2020. Passed House on 5/28/2020/.
- Summary:
  - This Bill is for the purpose of modifying provisions to the forgiveness of loans made to small businesses under the Paycheck Protection Program in response to COVID-19. The Bill establishes a minimum maturity of five years for a paycheck protection loan with a remaining balance after forgiveness; extends the covered period where a loan recipient may use the funds for expenses while remaining eligible for forgiveness; raises the non-payroll portion of a forgivable loan amount from the current rate of 25% to 40%; extends the period where an employer may



rehire or eliminate a reduction in employment, salary, or wages that would reduce the forgivable amount of the paycheck protection loan; and revises the period for paycheck protection loans.

#### H.R. 6965- Cash Refunds for Coronavirus Cancellations Act of 2020

- Latest Action: Introduced on 5/22/2020. Referred to Subcommittee on Aviation on 5/26/2020.
- Summary:
  - This Bill is for the purpose of requiring air carriers and ticket agents to offer full
    cash refunds for all cancelled tickets during the COVID-19 pandemic. This refund
    will take place regardless of whether the air carrier cancelled an entire flight or
    the passengers cancelled their individual tickets.

#### H.R. 6976- Service Assurance Act of 2020

- Latest Action: Introduced on 5/22/2020 and referred to House Committee on the Judiciary.
- Summary:
  - This Bill is for the purpose of exempting non-profit organizations from liability for any act or omission relating to harm arising from exposure by COVID-19. The Bill does not apply to act or omissions that constitute willful or criminal misconduct, gross negligence, reckless misconduct, or conscious and flagrant indifference to the rights or safety of the individual harmed.

- Introduced: 5/20/2020
- Latest Action: Passed Senate. Received in House on 5/22/2020. Held at desk on 5/22/2020. Hearings held in Senate on 6/3/2020.
- Summary:
  - This Bill is for the purpose of revising the authorization for Small Business Administration loan products linked to the Paycheck Protection Program in response to COVID-19.

- Committee: Senate- Banking, Housing, and Urban Affairs
- Introduced: 5/18/2020
- Latest Action: Introduced on 5/18/2020. Read Twice and referred to the Committee on Banking, Housing, and Urban Affairs on 5/18/2020. Hearings held in Senate on 6/2/2020.
- Summary:
  - O This Bill is for the purpose of providing \$500 billion for a Coronavirus Local Community Stabilization Fund to address the economic effects of COVID-19 on state, local, and tribal budgets. Additionally, the Bill is for the purpose of expanding the use of payments from the Coronavirus Relief Fund.

#### S.3742- RELIEF for Main Street Act

- Committee: Senate- Small Business and Entrepreneurship
- Introduced: 5/14/2020
- Latest Action: Introduced on 5/14/2020 and read twice and referred to Committee on Small Business and Entrepreneurship. Hearings held in Senate on 7/23/2020.
- Summary:
  - O This Bill is for the purpose of establishing the Small Business Local Relief Program for one year. The Bill states the Program shall allocate resources to states, local governments, and Native American tribes for providing assistance to certain small businesses and nonprofits that have lost revenue due to COVID-19.

## H.R.6800- The Heroes Act

- Committee: House- Appropriations; Budget; Ways and Means
- Introduced: 5/12/2020
- Latest Action: Passed House. Received in Senate and read for the first time on 5/21/2020. Placed on Senate Legislative Calendar. Read for the second time in the Senate on 6/1/2020. Referred to Committee on Small Business and Entrepreneurship and hearing held in Senate on 7/23/2020.
- Summary:
  - The Bill is for the purpose of responding to the COVID-19 outbreak and its impact on the economy, public health, state and local governments, individuals, and businesses. The Bill provides, among other things, 2020 emergency supplemental appropriations to federal agencies; payments to state and local governments; direct \$1,200 payments to individuals; expands sick and medical leave as well as unemployment; eliminates costs for COVID-19 treatment and requires employers to put in place exposure and control plans.

- Latest Action: Introduced. House- 5/12/2020 referred to the House Committee on Energy and Commerce and Committee on Ways and Means.
- Summary:
  - The Bill is for the purpose of requiring Centers for Medicate and Medicaid Services to establish a process for prescription drug plans under Medicare and Medicare Advantage in order to allow individuals to make coinsurance payments in installments, if the individual chooses to obtain the entire prescribed drug in a single fill.

# S.3681- Ensuring Health Safety in the Skies Act of 2020

- Committee: Senate- Commerce, Science, and Transportation
- Introduced: 5/11/2020
- Latest Action: Introduced on 5/11/2020. Placed on Senate Legislative Calendar under General Orders on 8/6/2020. Passed Senate on 9/30/2020. Held at House desk on 10/01/2020.
- Summary:
  - This Bill is for the purpose of requiring the Department of Health and Human Services, the Department of Homeland Security, and the Department of Transportation to form a joint task force on the operation of air travel during and after the COVID-19 pandemic. The Bill requires the task force to develop recommended requirements, plans, and guidelines to address the health, safety, security, and logistical issues relating to the continuation of air travel during the COVID-19 public health emergency, as well as the resumption of full operations at airports and increased passenger air travel after the COVID-19 public health emergency ends.

- Latest Action: Introduced on 5/08/2020. Passed House on 9/22/2020. Received in Senate and read twice and referred to committee on Banking, Housing, and Finance.
- Summary:



- This Bill is for the purpose of establishing the Consumer and Investor Fraud Working Group to prevent fraud during COVID-19. The working group will be required to report monthly regarding resources available to consumers, public enforcement actions, and related consumer complaints.

#### H.R. 6762- COVID-19 Earned Income Act

- Committee: House- Ways and Means
- Introduced: 5/8/2020
- Latest Action: Introduced. House- 5/8/2020 referred to the Committee on Ways and Means.
- Summary:
  - This Bill is for the purpose of setting forth a special rule for determining the amount of the earned income tax credit and the refundable portion of the child tx credit. The Bill allows a taxpayer to use the earned income of the preceding taxable year in computing credits if income is greater than the income for the current taxable year.

### S.3607- Safeguarding America's First Responders Act of 2020

- Introduced: 5/5/2020

  - The Secretary of the Health and Human Services Department issued an amendment to section 319F-3 of the Public Health Service Act to clarify that Covered Countermeasures under the Declaration include qualified pandemic and epidemic products that limit the harm COVID-19 may cause. On March 10, 2020 the Secretary issued a Declaration under the Public Readiness and Emergency Preparedness Act for medical countermeasures against COVID-19. On April 10, the Secretary made the first amendment the March 10 Declaration to extend liability immunity to covered countermeasures authorized under the CARES Act (85 FR 21012).

The Board is issuing two temporary changes to its prompt corrective action regulations by first, amending its regulations to temporarily enable the Board to issue an order applicable to all FICU to allow them to the waive earnings requirement for any FICU that is classified as adequately capitalized. Second, the Board is modifying its regulations with respect to specific documentation required for net worth restoration plans for FICUs that become undercapitalized. The temporary modifications will be in place until December 31, 2020.
